**Subject: Terms and Conditions for the Transport**

Dear Mr. President,

As you might know, the Test Event for the 2016 Olympic Games will be held in Rio, January 30 and 31.

Therefore, you will find attached the list of the selected officials (instructors, supervisors, referees) for the Test Event.

**The arrival of the qualified officials is fixed the 27<sup>th</sup> of January and the departure the 1<sup>st</sup> of February 2016.**

The travel agency which is working with United World Wrestling will booked the flight tickets for all the concerned people.

We kindly ask you therefore to answer the requests below **before the 20<sup>th</sup> of October 2015**. Past this deadline, your referee will be removed from the list:

1. To confirm the availability of your selected officials
2. To give the departure airport for each of your officials
3. To confirm the above mentioned dates\*

\* If one of your referees want to arrive earlier or depart later, he is allowed to do it but United World Wrestling won't cover his accommodation outside of these dates. Moreover, the flight ticket will be covered from the Departure Airport to Rio and return.

We also want to remind you that the selected officials for the Test Event are not necessarily qualified for the Olympic Games.

The choice and the qualification of the referees for the Olympic Games will be done later.

As all the officials were registered through Athena for the Senior World Championship, we should have all the passports. In order to avoid any problem during the booking of the flight tickets, please make sure that the expiry date goes at minimum until the beginning of August 2016.

The Visas fees will be covered by United World Wrestling but it is your duty to run the process in order to obtain it.
